Fabrizio Marrella is Professor of International Law and European Union Law at Cà Foscari University of Venice and a Dean at EIUC where he has contributed to make it a world renowned centre of excellence. He is a former Vice-Director of the Harvard University Venice program where he taught International Business Law. He is also a member of the International Law Association (ILA), the European Society of International Law (ESIL) and the Italian Arbitration Association (AIA).

Fabrizio holds Doctorates in International and Private Law from the University of Paris I Panthéon Sorbonne and the University of Bologna and in 1998 was awarded the Diploma of The Hague Academy of International Law.
